You are invited to participate in this research study as described below.

**Why is the research being conducted?**

The COVID-19 pandemic has contributed to increases in food scarcity and higher food prices. Food security is a genuine barrier to shifting populations out of extreme poverty. Regionally, women and children have experienced more hardships to accessing safe, affordable and nutritional foods during the COVID-19 pandemic. It is vital to understand the baseline food insecurity position in the region as a result of the pandemic. In agriculture and food systems, women experience more discrimination and challenges than men, in particular in accessing credit, seed, and markets. A crisis on the scale of COVID-19, where lockdowns and border closures have caused extensive disruption to food systems and access to food markets, is likely to have created challenges.

This research is being conducted to investigate the experiences and perspectives of women during the COVID-19 pandemic. Specifically, to understand individual experiences of food insecurity and economic impacts as a result of the pandemic.

**Who is undertaking the study?**

This study is funded by the Australian Centre for International Agriculture Research, and is being led by the Griffith Asia Institute, Griffith University, Brisbane, Australia, under the leadership of Professor Sara Davies and Associate Professor Robin E Roberts. The interviews are being conducted by Myanmar program lead Zin Mar Oo (zinmaroo@gmail.com).

**Why am I being invited to participate?**

You have been selected to participate because of your experience in the food sector, and the impact on your livelihood in the pandemic environment caused by COVID-19.

**What will I be asked to do?**

You will be invited to participate in an interview (phone or online or face-to-face) to discuss your personal experiences with the COVID-19 pandemic.

**How much time will the study take?**

We expect interviews to last approximately 45-60 minutes. The location will be best suited to you or conducted remote (phone or online).

**Are there any risks associated with participating in this study?**

There are no foreseeable risks to you as a result of participating in this research. The interview is about women's experience growing and selling food during first year of Covid-19 pandemic. You are free to discontinue the interview at any stage. If discussing your experiences in an interview causes any distress to you or your family, we encourage you to access support services from the Serenity Psychological Counselling Services <https://www.facebook.com/serenitycounselingsupport/>.

**What are the benefits of this research study?**

This study will develop knowledge about the ways that women have been affected and are responding to the COVID-19 pandemic. This knowledge could help to develop an understanding of how their communities might prepare for potential future changes and challenges.

**Can I withdraw from the study?**

Participation in this study is completely voluntary. If you agree to participate, you can withdraw from the study at any time.

**What will happen to my information?**

Your information will not be made public. Any identifiers will be removed from the data once collected, and the full dataset will be securely stored at Griffith University on the Chief Investigators password-protected computer. These records will be kept for a minimum of five years after any publishing opportunities have been exhausted, and destroyed when no longer needed. The information and results will be used in academic and industry publications and may be presented at conference events. At all times only aggregated data will be made public; no individual data will be presented or released.
